 - A question was raised by Sam Berns about the duration of service time for School Site members. 1 year versus 2 years and staggering of members.

- III. 2022-2023 QTES School Plan for Student Achievement (SPSA)
 - A. Review and Approval by Committee
 - 1. Melanie Patterson reviewed the Comprehension Needs Assessment for Quarry Trail and the State/ District data used (MAP) which is focused on Math and our overall goal to improve assessment performance of our Socio-Economically Disadvantaged children and students with IEPs. Even though we as a school have scored high we are striving to provide targeted instruction for specific children.
 - a) Question: Are children being pulled out for private instruction? Katie T. explains how all students are identified

and placed in learning groups (WIN) to receive instruction with peers at their same learning level.

2. Goal 1: Academic

- a) Looked at numbers in both ELA and Math and have a planned outcome of a 3% increase in both subjects.
- b) Discussed different systems and programs that will be used to help scores increase, Building Fact Fluency, Whitney High School Reading Club, Math+, Math Olympiad for 6th grade and the Innovation Station.

3. Goal 2: Behavior

- a) Provide a safe and inclusive school environment through a tiered support system for behavior with a minimum of 80% fidelity, specifically focusing on strengthening Tier 1 and 2 and building Tier 3 of Positive Behavior Interventions and Supports (PBIS), as measured by the Tiered Fidelity Inventory (TFI) by spring 2022.
- b) Reviewed Tier 1 PBIS- awards and expectations

Goal 3: Social-Emotional-Cultural

- a) Provide social-emotional learning opportunities, student and family mental health support, and an inclusive school climate in which students feel connected and part of the school.
- b) Review the Equity lens in all committees/ groups; Counseling on campus 1.5 days/wk; Care Solace-service for mental health/substance abuse services. Future plans to have Universal Screeners for social-emotional health (Tier 2). Plan to send out a Toolbox to parents to use at home.
